**AND TO APPOINT CO-LEAD AND LIAISON COUNSEL FOR PLAINTIFFS**

Plaintiff Zachary Elton (case no. C-15-21-CV-000496, Dec. 6, 2021), Plaintiff Eric White (case no. C-15-CV-21-000573, Dec. 22, 2021), Plaintiff Jefferey Reynolds (case no. C-15-cv-22-000215, Jan. 18, 2022) (collectively, “Plaintiffs”), and all Defendants in both of the above-captioned actions (the “Actions”) filed a Consent Motion pursuant to Maryland Rule 2-503(a)(1), requesting that the Actions be consolidated for all purposes. Plaintiffs also request that, as part of consolidation, the Court appoint Rigrotsky Law P.A., The Rosen Law Firm, P.A., and Johnson Fistel, LLP as Co-Lead Counsel for Plaintiffs, and Goldman & Minton, P.C. as Liaison Counsel for Plaintiffs, with Brown Goldstein & Levy, LLP serving as additional counsel for Plaintiffs.

Upon review and consideration of Plaintiffs’ Motion, it is hereby:

ORDERED that the Motion to Consolidate is GRANTED and that: (i) the Actions be consolidated for all purposes (the “Consolidated Action”); (ii) Plaintiff Zachary Elton’s case (case no. C-15-21-CV-000496) shall constitute the master file for the Actions; (iii) hereinafter, papers need only be filed in Case No. C-15-21-CV-000496; and (iv) all papers and documents previously served or filed in any of the cases consolidated herein are deemed a part of the record in the Consolidated Action; and it is further

ORDERED that Rigrotsky Law P.A., The Rosen Law Firm, P.A., and Johnson Fistel, LLP shall be appointed as Co-Lead Counsel for Plaintiffs, and Goldman & Minton, P.C. shall be appointed as Liaison Counsel for Plaintiffs. Brown Goldstein & Levy, LLP shall serve as additional counsel for Plaintiffs.
